

1. Association

This report shows the main activities that have been carried out by the Association *European Coordination Let's Liberate Diversity!* during the year **2021**. They have been divided into small chapters to give an overview of the single **activities** and a summary of the economic situation. In Annex the **complete account was created** with the accounting software "Banana 8" (https://www.banana.ch/en).

a. Secretariat

Since April 2019, the Association has the possibility to use a **workstation** inside the office of the member Rete Semi Rurali. The headquarters, called **Casa dell'Agrobiodiversità**, has a workspace, a meeting room, an agrobiodiversity library and the "Community Seed Bank" area. The Secretary uses the space together with RSR Staff on Monday - Friday from 09:00 to 17:00. No costs are currently charged to EC-LLD for the use of the office.

b. Board meetings

During the year 2021, the EC-LLD board organised **11 virtual meetings**: January 15th, February 4th, March 4th, April 1st, May 6th, June 3rd, July 1st, August 5th, September 2nd, October 5th, November 4th.

c. General Assembly 2021

The Ordinary Assembly was called for the day May 27th, 2021 from 16:00 to 18:00. In view of the COVID-19 circumstances and on the advice of the accountant based in Belgium, it was decided to hold a virtual meeting to carry out the administrative procedures. h. Accountant



In March 2018, we started a collaboration with an accountant - Didier Verelst - to follow all EC-LLD bureaucratic procedures - e.g. TVA, statute, personnel, budgeting - according to the Belgian laws. The collaboration continued throughout the year 2021.

2. Activities

Limitations due to the health situation continued in 2021. For EC-LLD the difficulties were at the heart of its action, in fact it was not possible to organize all the activities and physical forums that were planned. That's why the Secretariat has been reinventing EC-LLD's tasks by trying to "occupy" the digital and on-line space through webinars and Seed Policy Dialogues series. Towards the end of the year 2021, in-person activities resumed and it was possible to organize the extraordinary meeting during the Agroecology forum in Barcelona.

a. Seed Policy Dialogues

To discuss the political and legislative developments of the agricultural biodiversity movements, the European Coordination Liberate Diversity! (EC-LLD) launched in April 2021 a series of "virtual dialogues" with actors from different backgrounds. Each meeting, for a total of 8 appointments and with a turnout of about 50 participants, was divided into two parts: in the first one, the lawyer Fulya Batur exposed the issues of the monthly newsletter *Sprouts From Brussels* and, afterwards, the invited speakers presented and started a debate on the issues of their competence. The cycle, which ended in December 2021, was opened by the French association Inf'OGM while the following months were hosted, in order, the seed savers of Arche Noah, the coalition against patents No Patents on Seeds, the network for open source seeds initiatives GOSSI, the FAO treaty secretariat and RSR, the promoters of the UNDROP treaty and Via Campesina, the FAO Commission on Genetic Resources CGRFA and Pro Specie Rara, and finally APREBES to talk about the UPOV convention and its impact on farmers' rights.




Fig. 1- Some brochures of the Seed Policy Dialogues.

They had formally asked to become members of EC-LLD, but since it is a very large and structured entity, the board felt it was more useful for the time being to collaborate and not join directly. In the coming years we will see which formula is the best to strengthen the respective actions.

The European Network of Living Labs (ENoLL) is a global network of open innovation ecosystems (Living Labs) that places people at the centre of product and service development and innovation. a. DYNAVERSITY (2017 to 2021)


The project is finished in April 2021. During the year 2021, the 3rd manual in the series dedicated to CSBs was finished written in EN, IT, FR, ES. It was made also the EC-LLD promotional video (https://www.youtube.com/watch?v=lf5OEjUZV4s&t=116s) has also been translated the website into 3 languages with the Easyling technology.





b. GenRes bridge Project (2019 to 2021)

c. "Strengthen and Enlarging the European Coordination - LLD network" (2020 - 2023)

Written in 2021 and presented in September 2021, is the continuation of liveseed.eu project

University of Cardiff - not submitted

A project was wrote with researcher Poppy Nicol. Small Task for ECLLD (organization of 2 meetings).

United for Diversity - approved by members but not submitted yet

Written in 2021 and presented in September 2021, the continuation of liveseed.

Community Seed Bank Academy - lost

In December 2020, the three ECLLD organizations (Arche Noah, ProSpecieRara and Rete Semi Rurali) who have written the CSB Academy project with the Salvia Foundation, proposed to spend the final year of the project under the EC-LLD portfolio. Meetings have begun with the foundation to figure out how to present the project to their next board in May 2021. The foundation declined the project.

4. Communication and Media

a. Website

The website has been **updated** with events of the members and with articles shared by members on a weekly basis. In collaboration with RSP, it is included in a box called "*Legal Watch*". The new site changed in 2020 on wordpress platform and in 2021, thanks to Dynaversity, was translated into 3 languages.

c. Social media


